# Midwest Charity Horse Show

## CHECK LIST

Eliminate incomplete entry fees. Utilize this check list as your guideline.

Back numbers will not be issued until all information is complete. There are new rules and regulations for this year so please be prepared, and note the changes with your breed or division associations, the USEF rulebook, Midwest Charity Horse Show Prize List and on the Entry Form. Please be prepared with your equine health documentation.

All horse entering the facility that are competing or non-competing must have proof of Rhinopneumonitis (Rhino/Flu) vaccination within 6 months (See USEF rule: GR845 for complete rule)

### BEFORE YOU MAIL THE ENTRIES PLEASE REVIEW REQUIREMENTS BELOW:

- \_\_\_\_\_ Proof of current owner registration (horse/pony)
- \_\_\_\_\_ Proof of Negative Coggins
- \_\_\_\_\_ Proof of Rhinopneumonitis within 6 months (every horse/pony)  
GR845 Equine Vaccination Rule:  
1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian...

- \_\_\_\_\_ Three signatures on reverse side of entry blank
- \_\_\_\_\_ Proof of USEF current (2017) Competing membership for every owner, trainer and exhibitor. (Opportunity and Walk/Trot classes exempt)
- \_\_\_\_\_ Proof of AHHS (Hackney) current (2017) membership for every owner, trainer and junior exhibitor in Youth Medallion classes.
- \_\_\_\_\_ Proof of ASHA current (2017) competing membership for every owner, trainer and exhibitor (Opportunity and Walk/Trot classes exempt)
- \_\_\_\_\_ Proof of ARHPA current (2017) membership for every owner, trainer, and exhibitor.
- \_\_\_\_\_ Proof of ARHPA Roadster Horse Identification (ID) Number.
- \_\_\_\_\_ Current address for owner, trainer and exhibitor
- \_\_\_\_\_ Email address for trainer & owner (very important as this is how we can communicate changes and news releases to you regarding the show)
- \_\_\_\_\_ Non-Competing Horses and Ponies must be entered on entry form, and include non-competing fee, office fee, proof of negative coggins, and proof of vaccinations in compliance with health requirements of USEF GR845, State of Illinois Dept. of Agriculture, and Midwest Charity Horse Show Rules.
