CHECK LIST

Eliminate incomplete entry fees. Utilize this check list as your guideline.

Back numbers will not be issued until all information is complete. There are new rules and regulations for this year so please be prepared, and note the changes with your breed or division associations, the USEF rulebook, Midwest Charity Horse Show Prize List and on the Entry Form. Please be prepared with your equine health documentation.

BEFORE YOU MAIL THE ENTRIES PLEASE REVIEW REQUIREMENTS BELOW:

- _____ Proof of current owner registration (horse/pony)
- _____ Proof of Negative Coggins test and health certificate in compliance with Illinois Dept. of Agriculture requirements.
- _____ Proof of vaccinations within 6 months
USEF requires that at Federation licensed competitions, horses entering the show grounds must be accompanied by documentation of the Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management.
See USEF GR845 Equine Vaccination Rule.
- _____ Three signatures on reverse side of entry blank
- _____ Proof of USEF current (2019) competing membership for every owner, trainer and exhibitor. (Opportunity and Unrated Classes exempt) As of January 1, 2019, if you are a USEF competing member 18 years of age or older you are required to take the core Safe Sport training within 30 days of activating membership. Take the Safe Sport Training at USEF.org by logging into your member dashboard
- _____ Proof of AHHS (Hackney) current (2019) membership for every owner, trainer and junior exhibitor in Youth Medallion classes.
- _____ Proof of ASHA current (2019) competing membership for every owner, trainer and exhibitor (Opportunity and Walk/Trot classes exempt)
- _____ Proof of ARHPA current (2019) membership for every owner, trainer, and exhibitor.
- _____ Proof of ARHPA Roadster Horse Identification (ID) Number.
- _____ Proof of AMHA current (2019) membership for every owner, trainer and exhibitor.
- _____ Proof of AHA current (2019) membership for every owner, trainer and exhibitor.
- _____ Current address for owner, trainer and exhibitor
- _____ Email address for trainer & owner (very important as this is how we can communicate changes and news releases to you regarding the show)
- _____ Non-Competing Horses and Ponies must be entered on entry form, and include non-competing fee, office fee, proof of negative coggins, and proof of vaccinations in compliance with health requirements of USEF GR845, and State of Illinois Dept. of Agriculture.
